APPROPRIATION ORDINANCE NO. 11TH-02-2022

AN ORDINANCE PROGRAMMING THE AMOUNT OF FORTY THREE MILLION EIGHT HUNDRED NINETY SIX THOUSAND TWO HUNDRED EIGHTY PESOS AND 50/100 (P43,896,280.50) FOR THE VARIOUS EXPENDITURES IN THE GENERAL FUND OF MOLAVE, ZAMBOANGA DEL SUR AS PER SUPPLEMENTAL BUDGET NO. 3.

BE IT ORDAINED by the Sangguniang Bayan of Molave, Zamboanga del Sur, in session assembled, that:

SECTION 1. TOTAL AMOUNT. The Supplemental Budget No. 3 of the LGU of Molave, Zamboanga del Sur for CY 2022 amounted to Forty Three Million Eight Hundred Ninety Six Thousand Two Hundred Eighty Pesos and 50/100 (P43,896,280.50).
