A RESOLUTION VALIDATING AND ADOPTING MDC RESOLUTION NO. 16, S. 2024 WHICH ENDORSE GAD FPS RESOLUTION NO. 4, S. 2024 ENTITLED: "A RESOLUTION APPROVING THE REALIGNMENT OF UNUTILIZED GAD FUNDS FOR FY 2024 AMOUNTING TO FIVE HUNDRED THOUSAND PESOS (P500,000.00) TO OTHER GAD PROGRAM, PROJECT AND ACTIVITIES FOR APPROPRIATE ACTION BY THE SANGGUNIANG BAYAN".

WHEREAS, presented for consideration is MDC Resolution No. 16 s. 2024 endorsing GAD FPS Resolution No. 4, s. 2024 which outlined various GAD-related PPAs under FY 2024 budget in the total amount of P500,000.00 that needs to be realigned to other projects;

WHEREAS, the amount of \$2500,000.00 shall be realigned to finance the following priority projects of the LGU:

- 1. Supply, Delivery, and installation of three (3) units of 75 KVA transformers at the GAD Center (for ZAMSURECO application) - \$200,000.00;



WHEREAS, the Municipality of Molave, Zamboanga del Sur has an allocated budget for the Loan Amortization of the Public Market - Phase II Interest under the 20% Development Fund for FY 2024 in the total amount of Ten Million Three Hundred Fifty Thousand pesos (PhP 10,350,000);

WHEREAS, there is a need to realign the said funds to finance various development projects that are critical for the welfare and development of the municipality;

WHEREAS, the total amount to be realigned is One Million Six Hundred Thirty-Five Thousand Pesos (PHP 1,635,000.00) to be allocated as follows:

- 1. **Two Hundred Thirty-Five Thousand Pesos (PhP 235,000.00)** for the additional fund for the Removal and Relocation of street lights from Rizal Avenue to Junction Brgy. Blancia. The amount allocated in Supplemental Budget AIP No. 2 was Six Hundred Thirty-Five Thousand Pesos (PHP 635,000.00), which covers only the cost of materials. The additional PhP 235,000.00 is intended for labor expenses;
- 2. **Three Hundred Thousand Pesos (PhP 300,000.00)** for the additional fund for the Construction of a Comfort Room at Barangay Makuguihon. The amount previously appropriated in Supplemental Budget AIP No. 1 was also Three Hundred Thousand Pesos (PhP 300,000.00), and this additional budget is necessary to complete the project;
- 3. One Million One Hundred Thousand Pesos (PhP 1,100,000.00) for the additional fund for the Acquisition of one unit dump truck for garbage collection. This will enhance the solid waste management capability of the municipality;

WHEREAS, JMC No. 2013-01 item 6.5 states that the unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the Local Sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP;

WHEREAS, item 5.1.3.2 and 5.1.15 of COA Circular No. 2012-002 provide that:

a. "The release and use of LDRRMF shall be supported by LDRRMFIP for projects, programs and activities listed in the approved plan as incorporated in the local development, annual work and financial plan."

b. "The LDRRMFIP shall be reviewed and updated annually to include the activities funded from the unexpended QRF and DRRMF-MOOE of the previous years which were transferred to the Special Trust Fund."

WHEREAS, the council proposed the realignment of the continuing appropriation from FY 2020-2023 of LDRRM Fund presented to the Municipal Disaster Risk Reduction and Management Council during its meeting for coordination and consultation;

WHEREAS, the council sees the need to approve the proposed realignment as it is in accord with RA 10121;

WHEREAS, the MDRRM Council is requesting the Sangguniang Bayan to adopt and approve the realignment of continuing appropriation of Php 3,800,000.00 for the road concreting at Purok 2, Brgy. Sudlon, Molave, Zamboanga del;

NOW, THEREFORE, on motion made by Mrs. Romicel N. Carreon and was duly seconded by Mrs. Jerljune D. Casiño, the Municipal Disaster Risk Reduction and Management Council of Molave, Zamboanga del Sur, hereby

RESOLVED, as it is hereby resolved to approve the realignment of continuing appropriation of LDRRM Fund in the amount of Three Million, Eight Hundred Thousand Pesos (Php 3,800,000.00) for the road concreting at Purok 2, Brgy. Sudlon Molave, Zamboanga del Sur;

RESOLVED FURTHER, that copies of the foregoing resolution be submitted to the Sangguniang Bayan for adoption and approval.

Call to Order:

The MDC meeting was called to order at 10:00 A.M. by Chairperson Cyril Reo A. Glepa. The proceedings began with an opening prayer led by Dr. Arthuro S. Antiquina, Jr., creating an atmosphere of unity and purpose among the attendees.

Roll Call and Determination of Quorum:

The MDC Chairperson initiated the proceedings by calling the roll, confirming the presence of twenty-four (24) regular members and noting the absence of eighteen (18) members. With the confirmation of a majority in attendance, the MDC Chairperson formally declared the presence of a quorum, thereby authorizing the meeting to proceed with its scheduled agenda.

Minutes of the Meeting:

The MDC Chairperson, Dr. Cyril Reo A. Glepa, formally commenced the meeting by expressing his heartfelt gratitude to all members for their attendance and active participation. He highlighted the essential role that the Council's collective efforts play in advancing various municipal development initiatives.

Although the minutes of the previous meeting had been officially dispensed prior to the start of the session, Chairperson Glepa took a moment to read them for the Council's reference. Following this, he invited members to offer any clarifications, comments, or recommendations, ensuring that all key points were accurately captured and understood.

Mr. Ireneo Q. Glepa raised a concern regarding the improvement of the Municipal Plaza and Parks, particularly the installation of Christmas decorations for Paskuhan 2024, which is part of the 4th Supplemental Annual Investment Plan (AIP) for FY 2024. He pointed out that with the onset of the "ber" months, would be an ideal time to implement this project.

In response, MDC Chairperson informed the Council that the bidding process for the project had already been completed and the official notice had been posted. He expressed optimism that by November 15, the Municipal Plaza would be fully decorated in time for the Christmas season.

The MDC Chairperson then sought the Council's approval for this initiative. On a motion presented by Engr. Mark Daryll N. Bahinting, duly seconded by Hon. Earl Louise A. Glepa, Hon. Felimon A. Lomotos, and Hon. Chito Alcala, the minutes of the previous meeting was approved.

At this point, the MDC Chairperson presented the following agenda items for consideration and approval:

- 1. A Resolution endorsing MDRRMC Resolution No. 6, S. 2024 A resolution recommending the approval of the realignment of unutilized funds amounting to ₱3,548,640.79 for the acquisition of one (1) unit of a brand-new dump truck.
- 2. A Resolution endorsing MDRRMC Resolution No. 7, S. 2024 A resolution recommending the approval of the realignment from the construction of a road crossing at Barangay Sudlon to the concreting of the road at Barangay Sudlon.
- 3. A Resolution endorsing GAD FPS Resolution No. 4, S. 2024 A resolution endorsing the approval of the realignment of the Gender and Development (GAD) PPAs for CY 2024.
- Renaming of the Improvement of Comfort Room at Barangay Makuguihon to the Construction of a Comfort Room at Barangay Makuguihon under the 1st Supplemental Budget FY 2024.
- 5. Realignment of Development Fund From Loan Amortization (Public Market Interest Phase II) amounting to ₱535,000 to:
 - Additional funds for the construction of a comfort room at Barangay Makuguihon (₱300,000)
 - Additional funds for the removal and relocation of streetlights from Rizal Avenue to Junction Brgy. Blancia (₱235,000)
- Realignment of 1st Supplemental AIP FY 2024 from improvement of Dalaon Water System in the amount of 600,000 to Rehabilitation of Mainline at Purok Aquino, Barangay Miligan
- 7. Approval of the 5th Supplemental AIP FY 2024.

After the presentation of the agenda, the Chairperson called on the Council for its approval. On a motion presented by Hon. Renebert G. Esoler, duly seconded by Hon. Chito Alcala and Hon. Welie Cabasag, the agenda items were approved.

The MDC Chairperson proceeded to present the first agenda item, reading MDRRMC Resolution No. 6, S. 2024, titled:

"A Resolution Approving the Realignment of Unutilized Funds Amounting to Three Million, Five Hundred Forty-Eight Thousand, Six Hundred Forty Pesos and Seventy-Nine Centavos (Php 3,548,640.79) for the Purchase of a Dump Truck for Garbage Collection for the Municipality of Molave, Zamboanga del Sur"

After the reading of the resolution, Mr. Ireneo Q. Glepa raised a concern regarding the quality and specifications of the dump truck that can be acquired within the Php 3.5 million budget. He expressed doubt about whether a dump truck of good quality could be purchased at this price and suggested increasing the budget by Php 1.1 million to ensure the purchase of a more durable and efficient vehicle.

Hon. Buenafe supported this concern, emphasizing that the specifications for the dump truck should clearly require that the dump box be made of stainless steel to prevent corrosion and extend the vehicle's operational lifespan.

The MDC Chairperson acknowledged the validity of these concerns and agreed with the suggestions put forward by Mr. Glepa and Hon. Buenafe.

On a motion presented by Mr. Ireneo Q. Glepa and duly seconded by Engr. Mark Daryll N. Bahinting, the agenda item was approved, with the recommendation to increase the budget by Php 1.1 million and to ensure that the specifications of the dump truck include a stainless-steel dump box for durability.

The MDC Secretary continued with the reading of the next agenda item, titled:

"A Resolution Approving the Realignment of Continuing Appropriation of LDRRM Fund Allotted for the Construction of Drainage Crossing – Brgy. Sudlon, Along Barangay Sudlon, in the Amount of Three Million, Eight Hundred Thirty-Five Thousand, Four Hundred Eighty-Four Pesos and Sixty-Three Centavos (Php 3,835,484.63) in the Municipality of Molave, Zamboanga del Sur."

Following the reading of the resolution, the MDC Secretary further informed the Council that this budget was developed in response to requests from the farmers of Sudlon. They raised concerns about water overflow during heavy rains, which adversely affects their rice fields.

The farmers have requested the construction of a drainage canal that would treverse to the national highway. However, inquiries made to the Department of Public Works and Highways (DPWH) indicated that such a drainage system could not be implemented at this stage, as it was not feasible to construct the drainage canal after the road had already been concreted.

In light of this, the farmers' association opted to modify their request to focus instead on the concreting of the road at Purok 2, addressing their immediate needs while accommodating the constraints identified by the DPWH. On a motion presented by Hon. Joel M. Egipto and duly seconded by Hon. Chito Alcala and Hon. Miguel A. Buanafe Jr., the agenda item was approved.

The MDC Chairperson presented Agenda 3, A Resolution endorsing GAD FPS Resolution No. 4 S. 2024 entitled:

"A resolution approving the realignment of unutilized GAD funds for FY 2024 amounting to Five Hundred Thousand Pesos (PHP 500,000.00) to other GAD program, project, and activities for appropriate action by the Sangguniang Bayan"

The MDC Chairperson presented the unutilized funds from various GAD-related programs, projects, and activities (PPAs) under the FY 2024 budget, which were realigned to address critical infrastructure needs for the operationalization of the GAD Center, as follows:

The MDC Chairperson then opened the floor for any questions. Mr. Glepa raised a concern regarding the GAD Center, noting the urgent need for its immediate operationalization. He emphasized that the facility, given its size and potential, could significantly contribute to the municipality's revenue generation.

Mr. Glepa inquired if there is an existing budget allocation for the furniture and fixtures of the GAD Center. In response, the MDC Secretary confirmed that the budget for these items has already been allocated and will be available by January 2025. However, the Secretary highlighted that the GAD Center will not be functional unless there is a reliable power source, which is why the prioritization of the transformers is critical at this time.

Mr. Ireneo Q. Glepa reiterated the critical importance of making the Gender and Development (GAD) Center functional and operational as soon as possible. He emphasized the necessity to be prioritized to ensure that the facility will be fully operational by 2025. Mr. Glepa urged the Council to act decisively so that the center can start delivering essential services to the community.

The MDC Secretary further informed the body that the budget for hiring a focal person has already been allocated. This employee will be tasked with overseeing the daily operations of the GAD Center once it becomes operational. This key appointment is aimed at ensuring efficient management and service delivery.

Hon. Chito Alcala raised concerns regarding the construction of a drainage canal around the GAD Center. He noted that without proper drainage, all runoff water currently flows to Purok Makiangayon, exacerbating flooding issues in the area. Hon. Alcala pointed out that the waterways in Purok Makiangayon are blocked by the Daral Family, who own the land where the drainage is supposed to flow, making the area prone to flooding.

Hon. Chito Alcala added that if a drainage canal is constructed around the GAD Center, the water could be redirected to Guilingan Street, which would help resolve the flooding issues in Purok Makiangayon. Hon. Earl Louise A. Glepa and Engr. Mark Daryll N. Bahinting responded that the drainage canal project is already subject to bidding. However, they mentioned that the only remaining issue is connecting the new drainage canal to the existing canal on Guilingan Street.

The MDC Secretary also shared that this complication arises from the newly widened road, which has inadvertently covered the existing drainage canals in the area. To address this, Mayor Cyril Glepa has already submitted a formal letter to the Department of Public Works and Highways (DPWH), requesting the inclusion of a project in next year's budget to relocate the canal. Engr. Bahinting informed the Council that, according to the DPWH, they have planned three sections for road widening projects in Zamboanga del Sur. Since the Pagadian section has been relieved from the priority list, Molave is now a candidate to receive additional funding for drainage canal construction. Given that Molave is recognized as a flood-prone area, the DPWH is likely to prioritize this project to mitigate flooding risks.

Upon a motion presented by Hon. Chito Alcala, and duly seconded by Hon. Estillore and Hon. Cabasag, the agenda was formally approved.

The MDC Chairperson proceeded to present the fourth agenda, titled:

Renaming of the 'Improvement of Comfort Room' at Barangay Makuguihon to 'Construction of a Comfort Room' at Barangay Makuguihon under the 1st Supplemental Budget FY 2024.

The MDC Secretary provided the rationale for this proposal, explaining that while the 1st Supplemental AIP FY 2024 initially described the project as an "Improvement of Comfort Room," it has come to the attention of the body that no existing comfort room currently exists at the project site. Consequently, the term "improvement" is inaccurate, as there is no structure to improve upon.

The Secretary emphasized that this correction is essential, as proceeding with the term "improvement" in the project description could pose compliance issues during the bidding process. Specifically, the Commission on Audit (COA) would not be able to verify any existing structure on-site, which could lead to complications and delays in the procurement and audit process. To ensure clarity and compliance, the project title must be corrected to "Construction of a Comfort Room."

Following this explanation, a motion was presented by Engr. Mark Daryll Bahinting, duly seconded by Hon. Welie Cabasag and Hon. Vivencia M. Florentino, the agenda was subsequently approved.

The MDC Chairperson introduced the fifth agenda, concerning the Realignment of the Development Fund amounting to ₱535,000, originally allocated for the Loan Amortization Interest (Public Market Phase II), to the following:

- ₱300,000 for the additional funds for the construction of a comfort room at Barangay Makuguihon.
- ₱235,000 for the additional funds for the removal and relocation of streetlights from Rizal Avenue to Junction Brgy. Blancia.

The MDC Secretary explained that the realignment was made possible through savings from the loan amortization interest allocated under the 20% development fund. Upon reviewing the loan's interest calculations, it was discovered that while the project was initially scheduled for turnover in May 2024, it was only completed in July. Since the loan interest only begins accruing after the project is billed, and the project has not yet been billed, savings on the interest have been generated. These savings will now be realigned to support the relocation of streetlights and the construction of the comfort room in Barangay Makuguihon.

The MDC Secretary also referenced a letter from Engr. Carmelito Mendoza, the Municipal Engineer, addressed to Mayor Glepa on October 3, 2024, which formally requested approval for these two realignments.

During the discussion, Hon. Buenafe raised a concern about whether the relocation of the streetlights would affect the traffic lights installed in the area. The MDC Secretary responded that the contractor for the traffic lights has agreed to their relocation, with the understanding that the LGU will shoulder the associated costs. This condition has already been stipulated in the contract for the traffic light installation.

Upon a motion by Hon. Gerardo P. Gemelga, duly seconded by Hon. Alfonso M. Belevestre, the agenda was approved.

Moving forward, the Municipal Development Council (MDC) Chairperson introduced the sixth agenda item, titled:

Realignment of the 1st Supplemental AIP FY 2024: From Improvement of Dalaon Water System in the Amount of ₱600,000 to the Rehabilitation of the Water Mainline at Purok Aquino, Barangay Miligan.

The MDC Secretary informed the body that the initial budget allocation of ₱2.5 million for the improvement of the Dalaon Water System, as outlined in the 1st Supplemental Annual Investment Plan (AIP) for FY 2024, had undergone a reevaluation. Based on a comprehensive assessment by Water Superintendent Engineer Gil Basay, it was concluded that the required amount for the project had been reduced to ₱1.9 million. As a result, a surplus of ₱600,000 was identified.

It was thus proposed that this unutilized amount be realigned to fund the rehabilitation of the water mainline at Purok Aquino, Barangay Miligan. The MDC Secretary highlighted the urgent need to address the water supply issues in the area, noting that the rehabilitation of the mainline would enhance water distribution and provide critical relief to the residents of Barangay Miligan, especially during the dry season when water shortages are most acute.

The MDC Chairperson then called for a motion to approve the realignment of the ₱600,000 savings from the Dalaon Water System to the Purok Aquino mainline rehabilitation. Following a motion by Hon. Gerardo P. Gemelga, duly seconded by Hon. Alfonso M. Belevestre, the proposal was unanimously approved by the Council. The reallocation of funds will ensure the immediate commencement of the much-needed rehabilitation work in Purok Aquino, benefitting the local community.

After concluding the sixth agenda, the MDC Chairperson proceeded to present the seventh agenda item: Approval of the 5th Supplemental AIP FY 2024.

The MDC Chairperson called on MDC Secretary for the discussion of the 7th agendum which is the Approval of the 5th Supplemental AIP FY 2024. The MDC Secretary informed the council that this is the last supplemental AIP for the year. Summary of the PPAs of the 4th supplemental AIP is shown in the table below:

After the detailed presentation of the Programs, Projects, and Activities (PPAs) encompassed within the 5th Supplemental Annual Investment Plan (AIP) for Fiscal Year 2024, the Municipal Development Council (MDC) Chairperson opened the floor for any comments, suggestions, or recommendations from the members. Having given adequate time for deliberation, and with no further remarks or concerns raised, the Chairperson proceeded to seek the Council's approval of the 5th Supplemental AIP FY 2024.

A motion to adopt the plan as presented was formally moved by Hon. Gerardo P. Gemelga and duly seconded by Hon. Alfonso M. Belevestre Jr. With no opposition from the body, the motion was unanimously carried, thereby officially approving the 5th Supplemental AIP for Fiscal Year 2024.

Other Matters:

1. Solid Waste Management

The MDC Secretary informed the Council about the provisions of the Municipality's Solid Waste Management (SWM) Plan, emphasizing that each barangay council is required to designate a focal person for solid waste management. This individual will be responsible for monitoring the implementation of solid waste initiatives at the barangay level.

The MDC Secretary clarified that under the SWM Plan:

- Residual wastes are to be collected by the LGU.
- Recyclable wastes are to be managed by the barangay.
- Kitchen wastes are to be handled by individual households.

She further highlighted that the plan does not limit the requirement for a focal person or monitoring team to the Poblacion area alone. All barangays are mandated to comply with these responsibilities. She also informed the body that the Commission on Audit (COA), during their exit conference, mentioned that they would conduct random inspections of three barangays per district in Molave. This underscores the urgency for each barangay to establish a solid waste management task force, team, or appoint a designated focal person.

Mr. Ireneo Q. Glepa raised concerns about the apparent lack of awareness and compliance regarding the municipality's solid waste management policies. He observed that despite the existing ordinance, sacks of garbage are still being irresponsibly dumped in various places of the municipality. Mr. Glepa questioned whether the information, education, and communication (IEC) campaigns have been sufficient, noting that violations continue despite the ordinance in place.

In response, the MDC Secretary acknowledged the issue and explained the current penalties outlined in the ordinance. She noted that while the LGU previously enforced a

system of progressive penalties—issuing warnings for first offenses, assigning community service for second offenses, and imposing a fine of ₱1,500 for third offenses—this practice was flagged by the COA as non-compliant with the existing ordinance.

The COA pointed out that the ordinance stipulates direct monetary fines for violators, with no provisions for community service as a penalty. The MDC Secretary emphasized the need to strictly adhere to the ordinance moving forward, to ensure that enforcement aligns with the law and that penalties are appropriately imposed to deter violations.

The MDC Secretary further informed the body that a budget of ₱2 million has already been allocated and posted for the procurement of Closed-Circuit Television (CCTV) cameras. These cameras will be installed at identified strategic locations across the municipality, with the aim of addressing the ongoing issues related to solid waste management.

She noted that during the period when the previous CCTV system was operational, there was a significant reduction in the irresponsible disposal of garbage. The presence of CCTV cameras acted as a deterrent, with fewer instances of waste being improperly discarded. The MDC Secretary expressed optimism that the new CCTV installations would similarly contribute to alleviating the solid waste management challenges the municipality is facing.

In line with this, she emphasized that the LGU will no longer tolerate violations of the solid waste management ordinance. The fines outlined in the ordinance will be strictly enforced, without leniency for perpetrators. This, combined with the surveillance capabilities of the new CCTV system, is expected to significantly improve compliance and reduce instances of illegal dumping.

Hon. Liberato S. Arnaiz raised a concern regarding the accumulation of plastic bottles in the irrigation system of Barangay Dipolo. He highlighted that these plastic wastes are not generated by the residents of Dipolo but are instead carried in from other barangays. Hon. Arnaiz inquired if these plastic bottles could be brought to the Materials Recovery Facility (MRF) for proper disposal.

In response, the MDC Secretary clarified that the LGU's Materials Recovery Facility (MRF) is designed to handle residual wastes only and does not accept recyclable materials, including plastic bottles, unless they meet specific conditions. She reiterated that, under the Municipality's Solid Waste Management Plan, the responsibility for managing recyclable waste—such as plastic bottles—rests with the barangays. The LGU is tasked solely with the collection of residual wastes, and each barangay is expected to establish systems for the proper collection and processing of recyclables.

However, the MDC Secretary noted that clean and dry recyclables will be accepted by the MRF facility. She explained that the limited manpower at the MRF—currently only three personnel—makes it unfeasible to accommodate the cleaning and sorting of recyclables onsite, as the Commission on Audit (COA) suggests. Accepting dirty recyclables would create operational difficulties, including foul odors, as the MRF facility is located directly in front of the municipality's evacuation center. Therefore, the MRF will only accept clean and dry recyclables that can immediately be processed by the facility's shredder machine.

Furthermore, the MDC Chairperson inquired which barangays had not yet been visited by the LGU's Solid Waste Management (SWM) team to conduct advocacy campaigns. It was noted that Barangays Dontulan, Lower Dimalinao, and Dalaon had not yet hosted any advocacy activities. In response, the MDC Secretary assured the body that the LGU-SWM

team would prioritize these barangays and schedule advocacy sessions to ensure that all areas receive the necessary information and guidance on solid waste management.

2. Acquisition of Land for Solid Waste Processing Center

The MDC Chairperson informed the body about a proposal to acquire a 4-hectare parcel of land in Barangay Dontulan for the establishment of a Solid Waste Processing Center. The proposed site, however, raised concerns among members of the Council.

Hon. Felimon A. Lomotos expressed his concerns, stating that the location being considered is too far into Dontulan, near the boundary of Barangay Diwan. He further pointed out that the land's terrain is sloped and hilly, which may not be ideal for building a processing center due to potential logistical and operational challenges.

In response to this, Hon. Danilo P. Lumpayao suggested an alternative location in Barangay Gonosan. He recommended that a site visit be arranged to assess whether the land in Gonosan would be more suitable for the proposed Solid Waste Processing Center.

Adjournment:

On motion made by Hon. Chito Alcala which was duly seconded by Hon. Renebert G. Esoler, the Municipal Development Council Meeting adjourned at 1:10 pm.
