MUNICIPAL ORDINANCE NO. 12th-34-2026

AN ORDINANCE ESTABLISHING THE TRANSPORTATION ALLOWANCE OF NURSES UNDER THE NURSES DEPLOYMENT PROGRAM (NDP) AND MIDWIVES UNDER THE RURAL HEALTH MIDWIVES' PLACEMENT PROGRAM (RHMPP) ASSIGNED TO VARIOUS BARANGAYS IN THE MUNICIPALITY OF MOLAVE, BASED ON A FIXED FARE PER BARANGAY, WITH A MAXIMUM CEILING OF ONE THOUSAND PESOS (₱1,000.00) PER MONTH.

WHEREAS, the Local Government Unit of Molave is mandated under Sections 16 and 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, to promote and protect the health of its constituents and ensure the effective delivery of basic health services at the barangay level;

WHEREAS, nurses and midwives deployed under the Nurses Deployment Program (NDP) and the Rural Health Midwives Placement Program (RHMPP) are not granted per diem and travel allowances when assigned to upland and far-flung barangays, resulting in transportation expenses being personally shouldered by them;

WHEREAS, Executive Order No. 77 dated March 15, 2029 prescribes the guidelines on travel expenses and allowances of government officials and employees, including the requirement for approved travel orders and itineraries of travel, and applies only to personnel performing actual fieldwork and taking meals at their assigned stations, thereby excluding NDP Nurses and RHMPP midwives from per diem benefits;

WHEREAS, the grant of a transportation allowance based on a fixed and reasonable fare per barangay is necessary to support the uninterrupted delivery of essential health services and is not intended as additional compensation but as reimbursement for actual transportation expenses incurred;

WHEREAS, funds for the said transportation allowance shall be charged against the budget of the Municipal Health Office (MHO), subject to the usual accounting and auditing rules and regulations;

BE IT ORDAINED by the Sangguniang Bayan of the Municipality of Molave, in session duly assembled, that:
